

I. Participant Confirmation

German Forklift Truck Driving Championship, Solo Men/Solo Women/Company Team/NationsCup

I hereby confirm the following:

- I hold a valid driving license for industrial trucks in accordance with DGUV Regulation 68.
- I will comply with the safety instructions given by StaplerCup adjudicators and the safety regulations under DGUV Regulation 68 and will follow the instructions given by StaplerCup employees and adjudicators. I will accept the decisions of adjudicators as final.
- > I understand that I enter the course area at my own risk.
- I will wear appropriate clothing (tight-fitting pants and safety shoes).
- I will attend the safety training organized for the StaplerCup.
- I will not participate in the StaplerCup under the influence of alcohol or drugs or under the influence of doping substances in accordance with the German Anti-Doping Act (*Anti-Doping-Gesetz*) and will comply with random testing where necessary.
- Willful and serious damage to the course or industrial trucks or non-compliance with adjudicator instructions will result in immediate disqualification.

II. Privacy Policy (Information Obligations)



(1) Controllers under data protection law:

The regional championships and the grand finale of the StaplerCup are being run in "joint controllership" by the relevant regional dealers and Linde Material Handling GmbH, 63743 Aschaffenburg (hereinafter "LMH") as joint controllers (hereinafter "Controllers") in accordance with Art. 26 GDPR. LMH and the relevant dealers have entered into a contractual agreement on the cooperation in accordance with Art. 26 GDPR and, in particular, have defined the responsibilities of the two contractual partners.

(2) Personal data collected and purposes of processing:

The personal data provided by participants in the registration form and required to process the registration and hold the event itself [mandatory information is indicated with an asterisk (*)] is:

- First name, last name*
- Telephone number, cell phone number* for inquiries
- Address (street and house number, postal code, town/city)*
- Email address* for notification purposes

- Assessment of own concentration (for creation of DriverCard)*
- Assessment of own nerves (for creation of DriverCard)*

- Assessment of own speed (for creation of DriverCard)*

- Participation in DriverParty incl. number of companions*
- Photo upload for DriverCard*
- Favorite model*
- Motto*
- How long have you been driving forklift trucks for?*
- Choice: I'm employed by a company. /I'm self-employed/not an employee.*

For employees with a company, the following information also needs to be provided [mandatory information is indicated with an asterisk (*)]:

- Company name* and address* (street, building number, postal code, town/city)
- Work email address and telephone number*
- First name, last name, age of companions (for hotel bookings)*
- Expected number of companions (adults/children)*

We need your prior consent in case photos are taken of you. You can withdraw this consent at any time by emailing communications@kiongroup.com; you will not suffer any disadvantages if you do this. The purpose of the photos is to document and promote the StaplerCup in the media, including social media.

- (3) The personal data entered by participants in the registration form is collected, processed, and used by the Controllers for the purposes of holding and promoting the competition. The following personal data will be published on the website www.staplercup.com, in press releases of the results, and in print media reports, in particular also in rankings (ranking and results lists), possibly accompanied by photos of the individual participant or multiple participants. This personal data will also be provided to the reporting media for use in their reports.
 - Position achieved First and last name
 - Place of residence

- Points achieved
- Photo of presentation ceremony
- Where applicable, photo and video footage of the participant

In the event that a participant from the relevant regional championship achieves first, second, or third place in the grand finale of the German Forklift Truck Driving Championship (Solo Men/Solo Women/Company Team/NationsCup), the aforementioned data relating to the participant specified in this section (5) together with a photo of the presentation ceremony will be published on the website www.staplercup.com and made available to the media reporting on the results in this way. Said data will also be made available for retrieval and download.

Data may be passed on to third parties in the context of fulfilling the purpose stated above. Where this is the case, the Controllers have ensured by means of contractual agreements that the data transfer and processing complies with the data protection requirements of the GDPR, irrespective of where the processing takes place.

The personal data relating to participants that is collected in the registration form and the photos taken of participants during the course of the StaplerCup, as well as any photos of the presentation ceremony, will be stored by the Controllers and made available on the internet until the organization and implementation of the StaplerCup has completely finished. Qualification tables will be deleted the following year.

The participant also has the right to data portability.
